## What's New?

- No major changes to plan benefits
- Premium changes:
  - $\Rightarrow$  CIGNA Medical OAP Medicare Expand 6.9% increase
  - ⇒ KAISER Medical Senior Advantage 5.2% decrease for those enrolled in Medicare A&B
  - $\Rightarrow$  SCAN Health Care no change
  - $\Rightarrow$  CIGNA Dental HMO no change
  - $\Rightarrow$  CIGNA Dental PPO -5% decrease
