### 2022-23 School Safety Plan

School safety is the number one priority of all staff at Pomona (K-6). Pomona is a closed campus after school begins until at the end of the school day. All visitors check in at the office with our Raptor System and wear visitor's badges. Emergency preparedness materials are on hand in case of emergency. The school is inspected regularly by the Fire Department as well as the Health Department to ensure safe conditions for all. Pomona's focus for the 2021-2022 and 2022-2023 is to monitor and improve the ingress and egress procedures on campus. The safety plan safety plan was updated, reviewed, and discussed with faculty on August 16, 2021, approved by School Site Council on November 3, 2021, approved by the Local Board of Education on February 8, 2022.
