#### 15. PERSONNEL DIRECTOR:

Ms. Clark highlighted the following items:

- Clarified that the majority of the requested classification modifications were mostly based on changes to the reporting supervisor titles.
- California Department of Health has issued a mask mandate effective December 15, 2021 for approximately one month until January 15, 2022. The District has issued communication announcing this update to insure employees are in compliance.
- Within the last 18 months, the District has added 174 additional classified positions. During this current school year, beginning July 1, 2021, the Commission office has hired 175 classified employees, (82 replacements and 93 new positions, which includes approximately 30-40 promotions). Additionally, we have hired 60 new walk-on coaches and 235 returning coaches. The District has recognized the increased workload and added additional Human Resources staff.
- Announced the retirement of Stephanie Beck, Human Resources Technician, Classified Personnel, and introduced Elizabeth Peterson as her replacement.

### 16. PUBLIC NOTICE: REORGANIZATION

Ms. Michelle Barto, President of the Newport-Mesa Unified School District Board of Education, administered the oath of office to Commissioner Tristan Aley. The Board and Union Appointees approved Mr. Aley as Joint Appointee to the Personnel Commission at its November 16, 2021 meeting. The appointment took effect at noon on December 1, 2021.
