10. PERSONNEL DIRECTOR:

Ms. Clark highlighted the following items:

- Outlined changes to the NMUSD Board of Education, including the new officers; Karen Yelsey, President, Michelle Barto, Vice-President and Charlene Metoyer, Clerk. The Board also swore in three brand new Board Members/Trustees, Leah Ersoylu, Carol Crane and Krista Weigand. The new Board Members replaced, Martha Fluor, Dana Black and Vicki Snell.

Pam Saunders added her request for information regarding the number of classified staff that had submitted request for medical leaves associated with COVID. Pam also announced CSEA's installation of their Executive Board Members in January and will be sending invitations out to District Management.
